- 1. April Minutes
  - a. Amy moved to approve, Nicki seconded
  - b. Minutes approved with unanimous approval
- 2. Friends of Cottonwood / Auction update
  - a. Silent auction is live now through the 18th
  - b. Saturday is the live auction
- 3. 22-23 Budget
  - a. Added a little more allocation for facilities compared to the last draft
  - b. Adjusted ESSR staff allocation since the work hours have changed

  - d. Some new grants have just been awarded but they are not included here and would be direct expense related to the grant so essentially budget neutral
