## **Meeting Minutes**

- 1. Friends of Cottonwood
  - a. Auction update
    - i. Meeting on Friday morning to discuss follow ups with businesses and flyering.
    - ii. Haven't had any sponsorships yet. Want to focus on this in the immediate term.
    - iii. Have reached out to ~300 businesses and have about 100 donations so far.
  - b. Plant sale
    - i. This will be in March
  - c. Samantha is going to do a mixer soon to build community for the Friends group
  - d. Samantha is planning a book drive
  - e. Potentially supporting or coordinating with Samantha on other events
- 2. Financial updates
  - a. Amy to follow up with David re Auction goal for income and expenses
- 3. Weighted Lottery
  - a. Last year we implemented a weighted lottery for the first time and committed to reviewing it annually

- b. When we created the policy we looked at the definition of diverse schools and that specified that no single race constitutes a 70% and we have reached that with 66% is the largest racial block this year with white students.
