approach to teaching. We seek educators who have years of experience working to incorporate IEP and 504 accommodations into the curriculum and daily activities. Teachers at our school take charge of developing and implementing an integrated curriculum that centers indigenous perspectives while engaging 7-9 year olds and their families.

- Develop and implement 2nd and 3rd grade curriculum that aligns with state standards and PBE curriculum
- Work with Fieldwork Coordinator and other 2-3 teacher to design regular experiences off campus that make interdisciplinary connections to yearly themes
- Teach from a culturally responsive perspective that centers indigenous ways of knowing and place-based education for early childhood
- Foster creativity and self-expression in students through project based learning
- Manage curricular supplies and maintain an organized classroom
- Work with school administrators and special education teachers to provide accommodations and support for students with disabilities
- Collaborate with colleagues to integrate fieldwork and projects throughout different subjects
- Share a commitment to the success of the mission, goals and values of The Cottonwood School
- Organize and manage parent volunteers assisting in the classroom and in the field
